
Whereas, Articles of Charges, statement of imputation, Documents in support of articles of charges were framed out and served upon Shri Udham Dass vide letter No .Coop/SS/27/2015 dated 21.12.2015;

Whereas, vide this Department letter No.coop/SS/27/2015 dated 25.01.2016 the Registrar Cooperative Societies, J&K Jammu was requested to take appropriate action in respect of Mal functioning of Administrator Sainik Cooperative Housing Society Ltd. Jammu and findings be shared;

Whereas, Shri Udham Dass, vide his letter dated 8.01.2016 furnished his reply to the statement of Articles of Charges in the Charge Sheet and imputation in the Memorandum;

Whereas, vide this Department letter No; Coop/SS/27/2015 dated 15.02.2016 the reply furnished by the suspendee against the charges of the statement of Articles and imputation in the Memorandum along with its all enclosures received from Shri Udham Dass, Deputy Registrar Cooperative Societies was forwarded to the Registrar Cooperatives, Jammu for furnishing his comments/views in the matter;

Whereas, Registrar Cooperatives Jammu's letter No.RCS/SS/956 dated 26.02.2016 has furnished his report wherein he has recommended the



re-instatement of suspendee Officer by holding that in most of the charges the suspendee Officer has justified his action on documentary evidence and demand of the situation.

In view of the recommendation of Registrar Cooperative Societies, J&K vide his report mentioned above Shri Udham Dass, Dy. Registrar has been reinstated Vide Government order No. 23–Coop of 2016 dated 21-04-2016 with immediate effect.

However, the case is referred to the Commissioner of Enquires for inquiring the charges framed against Shri Udham Dass the then Deputy Registrar Cooperatives Societies (Agri) Jammu in respect of complaints regarding Sainik Cooperative Housing Society, Ltd. Sainik Colony, Jammu and on working of Cooperative school of Education and Research Institute Delli, Jammu and also the complaint pertaining to illegal appointment in Super Bazar.
