1. The amount shall be paid only after vouchsafing the availability of necessary funds.
2. The amount so drawn shall be spent during the current financial year
3. The Utilization Certificate of the above amount shall be provided to the Principal Accountant General well in time.
4. The pending O.B items if any in the books of Principal Accountant General shall be cleared.
5. All codal formalities shall be observed while incurring expenditure and no diversion of funds shall be made in any case.
6. Registrar Cooperative Societies J&K shall adhere to the terms and conditions set in the Government Order No.22- Coop of 2015 dated 06-08-2015.


