 - b) Renting out/leasing out of the shops lying vacant at JAKFED Rail Head Complex, Jammu.
 - c) Renting out/leasing out of the 04 out of 07 shops lying vacant at JAKFED Head Office B.C.Road and one vacant shop at Fruit Mandi, Jewel Chowk, Jammu.
 - d) Submitting of detailed project report regarding raising the constructions on the un-constructed shop sites at Fruit/Sabzi Mandi, Narwal, the properties lying at Miran Sahib and the property at Poonch to be put into

e) To look into the matter of staff rationalization in JAKFED by addressing the problem of over staffing and under staffing in various categories of The Committee will electrometric for retionalization of steff by way of

increasing/decreasing in different cadres of JAKFED.
