2. All the Codal formalities shall be observed while incurring expenditure and no diversion of funds shall be made in any case.
3. The utilization certificate of the above amount shall be provided to the Principal Accountant General well in time.
4. Funds shall be utilized for the purpose for which released.
5. Red Account shall be furnished to the concerned quarters.
6. Funds shall not be diverted for any other purpose.
7. The amount shall be paid only after vouchsafing the availability of necessary funds by the Registrar Cooperative Societies, J&K.
