**Government Order No. 15 -JK(Coop) of 2023**  
**Dated:- 23 -03-2023**

Sanction is hereby accorded to the introduction of Pay and Accounts Office System (P&AO) in the Cooperative Department. Accordingly, Accounts Officer posted in the office of the Registrar Cooperative Societies, J&K shall function as Pay and Accounts Officer. The Additional Registrars Cooperative Societies, Jammu/Kashmir and Deputy Registrar (Agri), Cooperative Societies at District level shall function as DDO's and operate on the treasuries they were already operating upon. The following officers shall now function as DDOs in the Cooperative Department:-


